

## *Yeats Annual*

### Notes for Contributors

*Yeats Annual* is published by [Open Book Publishers](#), and available in free to read formats, as well as ebook and printed editions on the publisher's [website](#) and at all major retailers, platforms and research libraries. It welcomes submission of articles, notes, and editions of texts.

Because it seeks to maintain and enhance its reputation for publishing new research at advanced level, *Yeats Annual* gives preference to original work with primary documents leading to the independent discovery of new fact about the poet's life, times, and work, over dissertation-level discussions of the existing secondary literature. Descriptions of research collections of interest to Yeats scholars and bibliographical information are also welcome, especially for our 'Notes and Documents' sections, and for occasional series such as "'Mastering What is Most Abstract': A Forum on *A Vision*".

#### **Manuscript submission and refereeing process**

Our two-stage submission process allows referees to comment upon submissions. The initial contribution (as an electronic file) ideally should be in the Editor's hands at least 18 months before publication of the issue for which it is intended. (We aim for publication in January of each year.) However, later submissions are considered if they seem appropriate as the volume takes shape, a flexible policy which allows for a more collaborative approach to current themes in research. The longer time frame is preferred so as to allow as required for considered augmentation and correction of conditionally accepted contributions.

Under normal circumstances we will reach a decision on a submission as soon as possible. Please supply your contribution in a form in which it can be refereed anonymously. If you refer to work you have previously published, please do so in the third person. Referees' comments will be communicated to contributors who are asked to bear the recommendations in mind while making final adjustments to their texts. The full membership of *Yeats Annual's* Editorial Board may be found in the preliminaries of the latest issue of *Yeats Annual* at [www.openbookpublishers.com/section/39/1](http://www.openbookpublishers.com/section/39/1). On occasion, the editor will approach further appropriate experts.

Your article as accepted for publication will need to be submitted as a Word file. Please use a PC-based program. If you use an Apple Macintosh program it will be necessary to ensure that your electronic version is PC compatible before sending it. We advise you to keep a back-up of your contribution. The final version of your article must be in our hands at least a year before publication.

#### **Style guide**

All quotations must be checked by authors (1) before final submission and (2) at proof stage. In every case, they should be checked against original sources, i.e. do not check the proofs merely against your typescript. In all cases, including from MSS, quote *verbatim* using original orthography and conventions, and do not 'silently emend' sources.

English conventions of orthography should be followed in your own text, and will be silently supplied at copy-editing stage. Also, please, bear in mind the following:

- Use single inverted commas outside double.
- Please do not indent paragraphs and do not use blank lines except to signal block quotes.
- Inset quotations should be marked off with one blank line between the quotation and preceding and succeeding text. The font size of block quotes should be two points smaller than the main text.
- Please do not use paragraph returns to mark the end of typographic lines.
- Please use footnotes rather than endnotes.

If useful, the publisher is happy to supply a MS Word template, complete with the necessary styles and page specifications. Please email [bianca@openbookpublishers.com](mailto:bianca@openbookpublishers.com) if you wish to be sent one.

*Yeats Annual* does not use 'Harvard' style (i.e. author/date in-text citations), and we do not print bibliographies with articles. Instead, please use MHRA layout in addition to the further instructions offered below:

- Citations of the works included on the list of 'Abbreviations' should be placed not in footnotes but in your text within parentheses, usually at the end of a sentence and before the full point. The latest list is enclosed, or see the latest number of *Yeats Annual* at [www.openbookpublishers.com/section/39/1](http://www.openbookpublishers.com/section/39/1).
- The citation form is '(*Au* 181)'. Note italics for abbreviation, no comma, no 'p.' or 'pp.'
- However, if the citation follows an inset quotation in verse or prose, the brackets should come at the end of the inset passage, and should have no further punctuation after the closing bracket, as follows:

he is never the bundle of accident and incoherence that sits down to breakfast; he has been reborn as an idea, something intended, complete. (*E&I* 509)

- Unless you have a specific reason for citing a particular edition, please quote Yeats's poems and plays from the two *Variorum Editions* using the corrected printings cited in the latest issue of *Yeats Annual*. Prose works should be cited from *Collected Edition of the Works* if available, but there are many occasions on which you will wish to offer double citations, using such older standard texts as the Macmillan (London) volumes of the 1950s and 1960s or relevant earlier editions as well.
- If you cite any other primary or secondary work frequently, please supply an appropriate abbreviation or other form of second reference in your first footnote, and place all further citations in your text. We would prefer a keyword or acronym of the title to be used. Such abbreviations should not be in italics. Please do not use the author's name, which can have uncontrollable associations (remember Matthew Arnold's 'Higginbotham, Stiggins, and Bugg'). Do not refer to individuals by their first names alone in your text viz. 'Maud', 'George', 'Olivia', 'Florence', 'Willie', 'Ezra' etc.

## Images

Illustrations are welcome and can be included in any given issue of the journal. If you would like to have your essay illustrated please read carefully the publisher's requirements about placement of captions in the text, image quality and copyright permissions, available to download [here](#). Please bear

in mind that authors are required to clear image rights well in advance of publication and that OBP is not able to absorb permission fees.

## **Production**

You will receive two sets of proofs of your essay. The first set in Word will show edits and comments. Please check them as carefully as possible and answer the queries indicated on the proofs as any substantive change can be made only at this stage. Once the manuscript is finalized the publisher will format text and images for publication and will provide contributors with a PDF file of the final proofs for your approval. Only minor corrections, to be marked using the Adobe Acrobat comment function, will be accepted at this stage.

## **Publication**

Open Book Publishers will make available Open Access editions upon publication, and will provide a complimentary downloadable PDF edition to all contributors, together with a 20% authors' discount on any book in their catalogue. OBP grants contributors the copyright in their individual articles. You should, therefore, be free to republish your article at any stage, before or after the publication of *Yeats Annual*, providing that full attribution is given.

## **Copyright**

OBP is not able to absorb permission fees, and you may want to limit the amount of quotation. In particular, try to avoid quoting the full text of any poem not by W. B. Yeats. As a guide for poetry, permission is required if you quote more than one-quarter of a single poem, or 25 lines or more from any number of poems. For prose, permission is typically required if you quote more than 400 words from a single passage, or 500 or more words from a single volume.

When submitting your final typescript for publication, please include a list of any quotations which exceed the above guidelines, and your letters of permission from appropriate estates or agents. The quotation of unpublished material by Yeats requires the permission of the Yeats Estate. Stewardship of the Yeats Estate is now in the hands of Amy Mitchell ([amitchell@unitedagents.co.uk](mailto:amitchell@unitedagents.co.uk)) also formerly of A. P. Watt, and her Assistant, Kat Aitken ([kaitken@unitedagents.co.uk](mailto:kaitken@unitedagents.co.uk)) at +44 (0)2032140931, who also handle, in addition to their estate work, foreign rights in a large number of countries.

Quotations from unpublished prose currently require the approval of Professor Roy Foster, FBA, ([roy.foster@history.ox.ac.uk](mailto:roy.foster@history.ox.ac.uk)) and those from unpublished letters the approval of Professor J. S. Kelly, St John's College, Oxford, OX1 3JP ([john.kelly@sjc.ox.ac.uk](mailto:john.kelly@sjc.ox.ac.uk)) on behalf of the Oxford University Press. Please send a copy of your essay to the above (as appropriate) when seeking permission to quote, and please mark the quoted passages clearly, copying in to your enquiry the Editor, at the email address given below.

Unpublished materials by other authors and artists should also be accompanied by full clearance from literary executors and estates, or owners of copyright holders. Certain libraries, such as the Berg Collection of the New York Public Library, also require that you obtain their permission before quoting from materials in their possession. It would be helpful if copies of your letters of authorization could be sent to the editor as they become available, and, at the latest, with final submission of your article.

Please also obtain permission where necessary from museums, libraries or publishers.
